RESOLUTION NO. SP- 5262, S-2011

**A RESOLUTION URGING TASK FORCE SIKAP BUHAY OF QUEZON CITY TO GIVE PREFERENCE TO SOLO PARENTS AS DEFINED UNDER REPUBLIC ACT NO. 8972, OTHERWISE KNOWN AS THE "SOLO PARENTS' WELFARE ACT OF 2000", IN THE AVAILMENT OF THE PUHUNANG PANGKABUHAYAN NG SIKAP BUHAY (PPSB) PROGRAM.**

*WHEREAS, it is the policy of the State to promote the family as the foundation of the nation, strengthen its solidarity and ensure its total development;*

*WHEREAS, Republic Act No. 8972, otherwise known as the "Solo Parents' Welfare Act of 2000", was enacted to provide benefits and privileges to Solo Parents and their Children, appropriating funds therefor and for other purposes;*

*WHEREAS, the City Council of the Quezon City expressed its full support to Republic Act No. 8972 by enacting ordinances such as Ordinance Nos. SP-1673, S-2006 and SP-1807, S-2007 for the massive registration and issuance of identification card to all the solo parents and their children to avail the benefits and privileges granted to them by the City;*

*WHEREAS, Article V of the Rules and Regulations in the Implementation of Republic Act No. 8972 mandate, among others, the local government unit to provide a comprehensive package such as livelihood development services for the solo parent, which include trainings on livelihood skills, basic business management, value orientation and the provision of seed capital or job placement;*


*WHEREAS, the Task Force Sikap Buhay of Quezon City was created to provide program to spur economic development and create employment through promotion and advocacy of effective entrepreneurship;*

*WHEREAS, most of the Solo Parents are constrained and obliged to take full responsibility of their dependents, emotionally and financially, hence, they should be given preference to avail the benefits under the program of Puhunang Pangkabuhayan ng Sikap Buhay (PPSB).*

**NOW, THEREFORE,**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED,** to urge, as it does hereby urge the Task Force Sikap Buhay of Quezon City, to give preference to Solo Parents as defined under Republic Act No. 8972, otherwise known as the "Solo Parents' Welfare Act of 2000", in the availment of the Puhunang Pangkabuhayan ng Sikap Buhay (PPSB) Program.
