RESOLUTION NO. SP- 5265, S-2011

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED ON APRIL 26, 2011 AT STA. CATALINA STREET, ALLEY II, BARANGAY HOLY SPIRIT, DISTRICT II, QUEZON CITY, COMPRISING OF SEVEN (7) HOUSES, TEN (10) FAMILIES AT TWO THOUSAND PESOS (P2,000.00) EACH FAMILY HOMEOWNER AND ONE THOUSAND PESOS (P1,000.00) EACH FAMILY RENTER/SHARER, THE FUND TO BE CHARGED AGAINST THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, a fire occurred on April 26, 2011 at Sta. Catalina Street, Alley II, District II, Barangay Holy Spirit, this City, wherein ten (10) families were rendered homeless;

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowers the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said event".

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the victims of fire that occurred on April 26, 2011 at Sta. Catalina Street, Alley II, Barangay Holy Spirit, District II, Quezon City, comprising of seven (7) houses, ten (10) families at two thousand pesos (P2,000.00) each family homeowner and one thousand pesos (P1,000.00) each family renter/sharer, the fund to be charged against the appropriation for Subsidies and Donations of the 2011 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
