A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF MIRE THAT OCCURRED ON APRIL 8, 2011 AT 15TH AVENUE AND HARVARD STREET, BARANGAY SOCORRO, DISTRICT III, QUEZON CITY IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUNDOR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the victims of fire that occurred on April 8, 2011 at 15th Avenue and Harvard Street, Barangay Socorro, District III, Quezon City in the amount of two thousand pesos (P2,000.00) per family owner and one thousand pesos (P1,000.00) per family renter/sharer which shall be taken from the Calamity or Emergency Fund or from any available funds of the City government.

RESOLVED, FURTHER, that the exact number and identities of the fire victims shall be determined by the Social Services Development Department. The Department shall process the necessary documents needed for the financial assistance granted under this Resolution.
