A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE THAT OCCURRED ON MARCH 10, 2011 AT NO. 92 19TH AVENUE, MURPHY, BARANGAY SAN ROQUE, DISTRICT III, QUEZON CITY IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

WHEREAS, because of this calamity, the victims are experiencing grief and anxiety, and the problem of building a new home and a place to move on:

WHEREAS, in order to lessen the difficulty and uplift the plight of the fire victims, it is hereby deemed proper to extend financial assistance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL, OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the victims of fire that occurred on March 10, 2011 at No. 92 19th Avenue, Barangay San Roque, District III, Quezon City, in the amount of two thousand pesos (P2,000.00) per family owner and one thousand pesos (P1,000.00) per family renter/sharer, to be taken from the Calamity or Emergency Fund or from any available funds of the City Government.

RESOLVED, FURTHER, that the exact numbers and identities of the fire victims shall be determined by the Social Services and Development Department. The Department shall process the necessary documents needed for the financial assistance granted under this resolution.
