RESOLUTION NO. SP- 5296, S-2011

**A RESOLUTION URGING THE CONGRESS OF THE PHILIPPINES TO AMEND SECTION 80 OF REPUBLIC ACT NO. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991, SO AS TO PROVIDE FOR THE ESTABLISHMENT OF PERSONNEL SELECTION BOARD TO ASSIST THE MUNICIPAL VICE MAYORS, CITY VICE MAYORS AND PROVINCIAL VICE GOVERNORS IN THE JUDICIOUS AND OBJECTIVE SELECTION OF PERSONNEL FOR APPOINTMENT AND/OR PROMOTION IN THEIR RESPECTIVE SANGGUNIANs.**

*WHEREAS, among the powers and duties of municipal vice mayors, city vice mayors and provincial vice governors as provided under the Local Government Code of 1991 is to appoint all officials and employees of their respective sanggunians, pursuant to Sections 445, 456 and 466 thereof, except those whose manner of appointment is specifically provided in Republic Act No. 7160, subject to civil service law, rules and regulations;*

*WHEREAS, Section 80 (b and c) of the Code provides for the establishments of a personnel selection board in every province, city and municipality in the manner as follows:*

*"(b) There shall be established in every province, city or municipality a personnel selection board to assist the local chief executive in the judicious and objective selection of personnel for employment as well as for promotion, and in the formulation of such policies as would contribute to employee welfare.*

*(c) The personnel selection board shall be headed by the local chief executive and its members shall be determined by resolution of the sanggunian concerned. A representative of the Civil Service Commission, if any, and the personnel officer of the local government unit concerned shall be ex-officio members of the board."*

*WHEREAS, the personnel selection board mentioned in Section 80 of the Code is established mainly to assist the local chief executive in the judicious and objective selection of their personnel for appointment and/or promotion, but there is none provided in the code to assist the vice mayors and vice governors in the appointment and/or promotion of their respective personnel and employees;*


*WHEREAS, to enable the vice mayors and vice governors to make a judicious and objective selection of their officials and employees for appointment in the local sanggunians, there is a need to create the personnel selection board to assist them in the process of selection and appointment.*

*NOW, THEREFORE,*

*BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Congress of the Philippines to amend Section 80 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, so as to provide for the establishment of personnel selection board to assist the municipal vice mayors, city vice mayors, and provincial vice governors in the judicious and objective selection of personnel for appointment and/or promotion in their respective sanggunians.*
