A RESOLUTION URGING PUBLIC EMPLOYMENT SERVICE OFFICE (P.E.S.O) TO STRENGTHEN THE SPECIAL PROGRAM FOR THE EMPLOYMENT OF STUDENTS (S.P.E.S) KNOWN AS "SUMMER JOB PROJECT" BY FORMULATING GUIDELINES THAT WILL PROVIDE FOR THE PROPER AND EFFICIENT IMPLEMENTATION OF THE SAME.

WHEREAS, it is a declared policy of the State to promote full employment and equality of employment opportunities for all;

WHEREAS, Republic Act No. 8759 mandated the establishment of Public Employment and Service Office (P.E.S.O) in every city to provide employment opportunities;

WHEREAS, there is a need to implement Republic Act No. 8759 so as to strengthen and expand the existing employment facilitation service and machinery of the government particularly at the local levels;

WHEREAS, in order to maximize the benefits offered by Republic Act No. 8759 there is a need to adopt guidelines that will provide for the proper and efficient implementation of the same in Quezon City;

WHEREAS, Public Employment Service Office is mandated by Department Order No. 07 Series of 2000 providing for the Implementing Rules and Regulations of Republic Act. No.8759, otherwise known as the "PESO ACT OF 1999", to promote and facilitate the employment of poor but deserving students during summer;

WHEREAS, the employment period under the S.P.E.S. shall be no less than fifteen (15) days nor more than forty five (45) days;-

WHEREAS, the salary scheme will be on a 60%-40% cost sharing. The Quezon City Government will act as the Employer shouldering 60% and the DOLE as the counter-part will shoulder 40% based on the current prevailing minimum wage;

WHEREAS, the program aims to help poor but deserving students in pursuing their education by encouraging employment during summer;

WHEREAS, the objective of S.P.E.S is to instill among youth a sense of social awareness, spirit of volunteerism, value of community service, discipline and work values.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the Public Employment Service Office (P.E.S.O.) to strengthen the Special Program for the Employment of Students (S.P.E.S) known as "Summer Job Project" by formulating guidelines that will provide for the proper and efficient implementation of the same.
