A RESOLUTION GRANTING FINANCIAL ASSISTANCE AMOUNTING TO FIFTY THOUSAND PESOS (50,000.00) TO THE BEREAVED FAMILY OF THE LATE EMILIANO D. 
NOW, THEREFORE,
