A RESOLUTION URGING THE METRO MANILA DEVELOPMENT AUTHORITY (MMDA) TO CONSTRUCT/ INSTALL TRAFFIC LIGHTS ALONG VISAYAS AVENUE CORNER ROAD 1 OF BARANGAY PROJECT 6, DISTRICT 1, QUEZON CITY.

WHEREAS, at present no traffic lights are installed along Visayas Avenue corner Road 1, Barangay Project 6, District 1, Quezon City;

WHEREAS, the aforesaid area does not only cause traffic gridlocks but likewise numerous vehicular accidents were reported therein thereby causing great inconvenience and danger to the motorists and pedestrian passing thereat;

WHEREAS, it is necessary to immediately construct/ install traffic lights in the said area so as to ensure safety and provide security for the motorists and commuting public, further avoiding recurrence of inconvenience and accidents thereat;
