**A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY PUBLIC SAFETY OFFICER (BPSO) DANILO CORTEZ OF BARANGAY PINAGKAI SAHAN, DISTRICT IV, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE CHARGED FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2011 GENERAL FUND PURSUANT TO ORDINANCE NO. SP-1207, S-2002, AS AMENDED BY ORDINANCE NO. SP-1860, S-2008.**
