RESOLUTION NO. SP- **5342** S-2011

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE TO THE AUGUST 10, 2011 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF TWENTY (20) FAMILIES AT ROAD 8 CORNER ROAD 1, BARANGAY BAGONG PAG-ASA, DISTRICT 1, QUEZON CITY AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/ SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF FUND THEREOF.

WHEREAS, on August 10, 2011 at Barangay Bagong Pag-asa, specifically Road 8 corner Road 1, a fire burned the houses of twenty (20) families, who are now in dire need of financial assistance;

WHEREAS, because of this calamity, they are experiencing difficulties;


WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowered the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance to the victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following the said events".


NOW, THEREFORE,

Bautista, to extend financial assistance to the August 10, 2011 victims of fire that burned the residential houses of twenty (20) families at Road 8 corner Road 1, Barangay Bagong Pag-Asa, District 1, Quezon City at two thousand pesos (P2,000.00) per family owner and one thousand pesos (P1,000.00) per family renter/sharer which shall be taken from the calamity or emergency fund of the City Government or from any available source of fund thereof.
