**WHEREAS, Presidential Proclamation No. 683, signed by President Corazon C. Aquino on January 28, 1991, declares February of every year as Philippine National Arts Month;**

**WHEREAS, the National Commission for Culture and the Arts has elevated the celebration of the Arts Month into an international status in order to encourage international participation and boost the tourism industry of the country;**

**WHEREAS, Section 3 (b) of Republic Act No. 9593, otherwise known as the Tourism Act of 2009, provides that the state shall "encourage activities and programs which promote tourism awareness, preserve the country's diverse cultures and heritage, and instill a sense of history and a culture of tourism among the youth and the populace";**
