RESOLUTION NO. SP- **5351**, S-2011

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA TO EXTEND FINANCIAL ASSISTANCE IN THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) TO THE VICTIMS OF MUD SLIDE WHICH OCCURRED LAST AUGUST 2011 AT SUBIC, PROVINCE OF ZAMBALES TO BE TAKEN FROM THE FUNDS OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, the onslaught by Typhoons "Egay" and "Falcon" brought devastation in most part of our country including Central Luzon;

WHEREAS, on August 2011, a portion of a mountainside eroded bringing mudslides over Sitio Malinta, Barangay Asinan, Subic, Zambales damaging properties and belongings;

WHEREAS, more or less One Hundred (100) houses were buried in mud and families were evacuated to Barangay Halls and Covered Courts;

WHEREAS, the Municipal Mayor of Subic, Province of Zambales is requesting the Quezon City Government through the Office of the City Mayor for assistance to cope with the expenses in relation to the calamity;

WHEREAS, in response to the request of the Municipality of Subic, Zambales, the Quezon City Government through the Honorable Mayor Herbert M. Bautista will extend financial assistance in the amount of Five Hundred Thousand Pesos (P500,000.00) to be taken from the funds of the Office of the City Mayor.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista to extend financial assistance in the amount of Five Hundred Thousand Pesos (P500,000.00) to the victims of mud slide which occurred last August 2011 at Subic, Province of Zambales to be taken from the funds of the Office of the City Mayor.

RESOLVED, FURTHER, that the said financial assistance shall immediately and officially transmitted to the Municipality of Subic, Province of Zambales through the Honorable Mayor Jefferson F. Khonghun.
