RESOLUTION NO. SP- **5355**, S-2011

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE FORMER BARANGAY PUBLIC SAFETY OFFICER (BPSO), DANILO S. CORTEZ OF BARANGAY PINAGKAISAHAN, DISTRICT IV, CUBAO, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) TO BE TAKEN FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.
