A RESOLUTION URGING THE LOCAL SCHOOL BOARD OF QUEZON CITY TO RESTORE THE HOME STUDY PROGRAM IN DISTRICT II PUBLIC HIGH SCHOOLS.

WHEREAS, education centralized to development strategies with full use of resources available — above all the human resources. This means that all parts of the populace must receive education and training of some kind so that they can participate in the development process as more productive citizens and are able to play their roles effectively and productively;

WHEREAS, the Local School Board, due to limited logistical support has temporarily discontinued the Home Study Program in District II public high schools and the affected schools are the following:

Doña Rosario High School - 400 students
Batasan Hills National High School - 800 students
Commonwealth High School - 600 students
Holy Spirit National High School - 500 students

WHEREAS, it is with this deep concern that the government recognizes the importance of Home Study Program for public high school in consonance with the mandate of 1987 Constitution, particularly in Article XIV, Section 2 (4 and 5), to wit;

"The state shall encourage non-formal, informal and indigenous learning system, as well as self-learning independent, and out-of-school study programs, particularly those that respond to community needs, and provide adult citizens, the disabled, and out-of-school youth with training in civics, vocational efficiency and other skills."
