A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO FLYING V (TWA, INC.) SERVICE STATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE STATION (FLYING V SERVICE STATION) AND OTHER RELATED SERVICES TO BE LOCATED AT SCOUT BORROMEO STREET CORNER MOTHER IGNACIA STREET, BARANGAY SOUTH TRIANGLE, QUEZON CITY.

WHEREAS, petitioner Flying-V (TWA, INC.) Service Station, a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Station (Flying-V Service Station) located at Scout Borromeo Street, corner Mother Ignacia, Barangay South Triangle, Quezon City;

WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Flying-V (TWA, INC.) Service Station has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a gasoline station will provide employment and promote economic development in the City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby, authorize the issuance of a Special Use Permit to Flying-V (TWA, INC.) Service Station for the construction and operation of a Gasoline Station (Flying-V Service Station) and other related services to be located at Scout Borromeo Street corner Mother Ignacia, Barangay South Triangle, Quezon City.
