A RESOLUTION GRANTING FINANCIAL ASSISTANCE AMOUNTING TO FORTY THOUSAND PESOS (P40,000.00) TO THE BEREAVED FAMILY OF THE LATE PABLO S. ABIOG, FORMER BARANGAY KAGAWAD BARANGAY SAN ANTONIO, DISTRICT I, QUEZON CITY, TO BE TAKEN FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND IN THE CITY TREASURY.
