RESOLUTION NO. SP- **5402**, S-2011

A RESOLUTION AUTHORIZING THE GRANTING OF FINANCIAL ASSISTANCE TO SEVENTY (70) FAMILIES WHO WERE VICTIMS OF FIRE THAT OCCURRED ON AUGUST 27, 2011 AT BAROROT COMPOUND, BARANGAY KATIPUNAN, DISTRICT I, QUEZON CITY AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2011 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS FOR THE PURPOSE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the granting of financial assistance to seventy (70) families who were victims of a fire that occurred on August 27, 2011 at Barorot Compound, Barangay Katipunan at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, which shall be taken from the appropriation for Subsidies and Donations under the 2011 Annual Budget of the Office of the City Mayor or any available funds for the purpose.
