A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO PILIPINAS SHELL PETROLEUM CORPORATION GAS STATION FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT LOTS 4, 5, 6, 7, 8, 9 AND 10 (PCS-007404-004290-D), CONGRESSIONAL AVENUE EXTENSION, BARANGAY PASONG TAMO, QUEZON CITY.

WHEREAS, petitioner Pilipinas Shell Petroleum Corporation, a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Filling Station located at Lots 4, 5, 6, 7, 8, ,9 and 10 (PCS-007404-004290-D), Congressional Avenue Extension, Barangay Pasong Tamo, Quezon City;

WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-0918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;

WHEREAS, Pilipinas Shell Petroleum Corporation has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a Gasoline Filling Station will provide employment and promote economic development in the City. γ
