WHEREAS, petitioner Uno Fuel, Inc. a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline filling station located at Lot 3, Block 2, Zabarte Road, Barangay Kaligayahan, Novaliches, Quezon City;

WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;

WHEREAS, Uno Fuel, Inc. has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City
