RESOLUTION NO. SP- 5414, S-2012.

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO UNIOIL PETROLEUM PHILIPPINES, INCORPORATED FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT NO. 1009 E. DELOS SANTOS AVENUE (EDSA), VETERANS VILLAGE, PROJECT 7, QUEZON CITY.

WHEREAS, petitioner Unioil Petroleum Philippines, Incorporated, a business entity duly registered under Philippine laws is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline filling station located at No. 1009 E. Delos Santos Avenue (EDSA), Veterans Village, Project 7, Quezon City;

WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000, as amended;

WHEREAS, Unioil Petroleum Philippines, Incorporated, has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;)
