RESOLUTION NO. SP- 5420 , S-2012

A RESOLUTION AUTHORIZING THE ISSUANCE OF A CERTIFICATE OF EXCEPTION TO SHELBE REALTY AND DEVELOPMENT CORPORATION, FOR THE CONSTRUCTION OF A FOUR (4)-STOREY RESIDENTIAL BUILDING WITH PENTHOUSE LOCATED AT LOT 8, BLOCK D-4, NO. 102 MOLAVE STREET, BARANGAY DUYAN-DUYAN, QUEZON CITY, ALLOWING DEVIATION FROM THE RESTRICTIONS OF THE QUEZON CITY COMPREHENSIVE ZONING ORDINANCE NO. SP-918, S-2000, AS AMENDED.

WHEREAS, Shelbe Realty & Development Corp., represented by its Vice President Mr. Ramon B. Salas, is applying for a Certificate of Exception for the construction of a Four (4)-storey residential building with Penthouse located at Lot 8, Block D-4, No. 102 Molave Street, Barangay Duyan-Duyan, Quezon City;

WHEREAS, the proposed project will not adversely affect public health, safety and welfare and is in keeping with the general pattern of development in the community;

WHEREAS, in accordance with the provisions of Article V, Article VI, ons 3, 4 and 11 and Article VIII, Section 3 of Ordinance No. SP-918, S-2000, as amended and its Implementing Rules and Regulations, an Exception is required for the said project.
