WHEREAS, the said House Bill aims to allow only an accredited drivers to drive public utility buses and require bus operators to pay these drivers a fixed salary;

WHEREAS, bus drivers are only paid through commission basis, they tend to stretch their hours of work so as to earn sufficient income generated from the fare they collect and after paying the required boundary to their bus operators;

WHEREAS, to ensure that no incompetent drivers of public utility buses are allowed to drive the same and further avoid vehicular accidents along our City's main thoroughfare, drivers are required to undergo a training and accreditation program before they are allowed to ply the streets.


