WHEREAS, petitioner Newpetro Gas Station Corporation, a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a gasoline filling station located at Anonas Street corner Tindalo and Aguho Streets, Barangay Claro, Project 3, Quezon City;
