RESOLUTION NO. SP- 5429 , S-2012

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF FORMER SK CHAIRMAN (2002-2007) KACY ERO CIMAFRANCA OF BARANGAY ESCOPA III, DISTRICT III, QUEZON CITY IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) CHARGEABLE AGAINST THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY IN COMMEMORATION OF HER SERVICE TO THE COMMUNITY, ASSISTANCE AND FOR OTHER PURPOSES.

WHEREAS, the City Government, as a token of gratitude for the humble service of its Barangay Officials, should convey sympathy and condolences by extending financial assistance to the bereaved family of the late former SK Chairman Kacy E. Cimafranca;

BE IT RESOLVED BY THE CITY COUNCIL, OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to extend, as it does hereby extend financial assistance to the family and surviving heirs of former SK Chairman (2002-2007) Kacy Ero Cimafranca of Barangay Escopa III, District III, Quezon City in the amount of Forty Thousand Pesos (P40,000.00) chargeable against the appropriation for Subsidies and Donations of the 2012 annual budget of the Office of the City Mayor or from any available funds of the City Treasury in commemoration of her service to the community, assistance and for other purposes.
