RESOLUTION NO. SP- 5438, S-2012

A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE HONORABLE RENE DE LEON, FORMER BARANGAY KAGAWAD OF BARANGAY MASAMBONG, DISTRICT I, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) IN RECOGNITION OF HIS DEDICATED AND EXEMPLARY SERVICE TO HIS BARANGAY AND TO THE CITY, TO BE CHARGED FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, as a token of gratitude and recognition of his loyal service to the barangay and to the city as a whole, it is appropriate to provide the bereaved family of Kagawad Rene De Leon some financial assistance to somehow ease their pain and loss.
