A RESOLUTION RATIFYING THE MEMORANDUM OF AGREEMENT (MOA) ENTERED INTO BY AND BETWEEN THE QUEZON CITY PUBLIC LIBRARY, REPRESENTED BY CITY LIBRARIAN, MS. EMELITA VILLANUEVA AND THE SANGGUNILANG BARANGAY OF VETERANS VILLAGE FOR THE ESTABLISHMENT AND OPERATION OF A PUBLIC LIBRARY AT A BUILDING INSIDE THE BARANGAY HALL COMPLEX LOCATED AT BANSALANGIN STREET, PROJECT 7, THIS CITY.

WHEREAS, it is the policy of the Quezon City Government to promote and enhance the intellectual development of its residents through the establishment of learning facilities like computer learning centers and libraries;

WHEREAS, in order to achieve the said goals, the Quezon City Public Library, as represented by City Librarian, Ms. Emelita L. Villanueva, and the Sangguniang Barangay of Barangay Veterans Village, herein represented by Punong Barangay, Hon. Gideon F. Gener, have entered into a Memorandum of Agreement for the purpose of enhancing the operation of a public library in the building donated by Representative Vincent "Bingbong" Crisologo, inside the Barangay Hall Compound located at Bansalangin Street, Project 7, Quezon City;
