RESOLUTION NO. SP- 5444, S-2012

A RESOLUTION GRANTING A SPECIAL USE PERMIT FOR THE OPERATION OF A FUNERAL PARLOR WITH MORGUE TO ST. PETER CHAPEL (LUZON), INC. AT NO. 262 G. ARANETA AVENUE, BARANGAY DOÑA IMELDA, DISTRICT IV, QUEZON CITY.

WHEREAS, Section 458 (4) (ix), Article III, Title III of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants in the Sangguniang Panlungsod the power to regulate the establishment, operation and maintenance of funeral parlors, subject to existing laws, rules and regulations;

WHEREAS, St. Peter Chapel (Luzon), Inc. is applying for a Special Use Permit for the operation of a Funeral Parlor with Morgue at No. 262 G. Araneta Avenue, Barangay Doña Imelda, District IV, Quezon City, where seven (7) viewing chapels are to be utilized;

WHEREAS, the said applicant is technically and financially capable to operate and maintain a funeral parlor and in fact has complied with the requirements set forth under City Ordinance No. SP-918, Series of 2000, as amended, and its Implementing Rules and Regulations;
