RESOLUTION NO. SP- 5447 . S-2012

A RESOLUTION STRONGLY URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE TO THE SEPTEMBER 30, 2011 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF THREE HUNDRED TWENTY SEVEN (327) FAMILIES AT MAUBAN STREET AND DAGOT STREET CORNER BIAK NA BATO STREET, BARANGAY MANRESA, DISTRICT 1, QUEZON CITY AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER WHICH SHALL BE TAKEN FROM THE CALAMITY OR EMERGENCY FUNDS OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE SOURCE OF FUNDS THEREOF.

WHEREAS, on September 30, 2011 at Barangay Manresa, specifically in Manban Street and Dagot Street corner Biak na Bato Street, a fire occurred that burned the houses of three hundred twenty seven (327) families, who are now in dire need of financial assistance;

WHEREAS, because of this calamity, they are experiencing difficulties resulting from the incident:

WHEREAS, Section 458 (1) (iv) of the Local Government Code of 1991 empowered the Sangguniang Panlungsod to "adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said events".

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance to the September 30, 2011 victims of fire that burned the residential houses of three hundred twenty seven (327) families at Mauban Street and Dagot Street corner Biak no Bato Street, Barangay Manresa, District 1, Quezon City at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, which shall be taken from the calamity or emergency funds of the City Government or from any available source of funds thereof.
