"Resolution inviting Quezon City to forge a sisterhood agreement with the Municipality of Caoayan, Ilocos Sur."

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to express, as it does hereby express the warm acceptance of the Quezon City Government to the desire of the Sangguniang Bayan of Caoayan, Ilocos Sur, to establish a Sisterhood Relationship.
