RESOLUTION NO. SP- 5459, s-2012

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE DARWIN B. BITONIO, AN INCUMBENT REGULAR BARANGAY PUBLIC SAFETY OFFICER (BPSO) OF BARANGAY COMMONWEALTH, QUEZON CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) CHARGEABLE AGAINST THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUND OF THE CITY TREASURY.

WHEREAS, the services rendered by the late BPSO Bitonio contributed in the maintenance of peace and order in the barangay and the city in general;

WHEREAS, it is fitting to recognize the valuable services of the late BPSO Bitonio by extending financial assistance to his bereaved family.


NOW, THEREFORE,
