RESOLUTION NO. SP- 5460, S-2012

A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE HONORABLE GIL H. FLORDELIZ, FORMER BARANGAY KAGAWAD OF BARANGAY VASRA, DISTRICT 1, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) IN RECOGNITION OF HIS DEDICATED AND EXEMPLARY SERVICE TO HIS BARANGAY AND TO THE CITY, TO BE CHARGED FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.
