RESOLUTION NO. SP. 5461 S-2012

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE FORMER PUNONG BARANGAY EDILBERTO RIVERA OF BARANGAY QUIRINO 2C, DISTRICT III, QUEZON CITY, IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) TO BE CHARGED FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.
