RESOLUTION NO. SP- 5475, S-2012,

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD JERIC ANGLO EVANGELISTA OF BARANGAY SOCORRO, DISTRICT III, QUEZON CITY, IN THE AMOUNT OF FIFTY FIVE THOUSAND PESOS (P55,000.00), TO BE CHARGED FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
