RESOLUTION NO. SP- 5482, S-2011

A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE BARANGAY KAGAWAD GERRY I. 
*WHEREAS, his untimely death, has caused pain and mental anguish not only to his surviving family, but also to the people of the Barangay he had served;*
