**A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE FAMILY AND SURVIVING HEIRS OF THE LATE FORMER BARANGAY CAPTAIN RICARDO V. MAYNITE OF BARANGAY BAGONG SILANGAN, DISTRICT II, QUEZON CITY, IN THE AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) TO BE CHARGED AGAINST THE APPROPRIATION FOR SUBSIDIES AND DONATIONS UNDER THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.**

**BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to the family and surviving heirs of the late former Barangay Captain Ricardo V. Maynite of Barangay Bagong Silangan, District II, Quezon City in the amount of Fifty Thousand Pesos (P50,000.00) to be charged against the appropriation for Subsidies and Donations under the 2012 annual budget of the Office of the City Mayor or from any available funds in the City Treasury.**
