RESOLUTION NO. SP- 5488, S-2012

A RESOLUTION PROVIDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE EMILIO TAMAYO, A FORMER MEMBER OF THE SANGGUNANG PANLUNGSOD, QUEZON CITY, FOR THE CONTINUOUS YEARS OF SERVICE FROM 1988-1998, WHO DIED ON DECEMBER 22, 2011, IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) IN RECOGNITION OF HIS DEDICATED AND EXEMPLARY SERVICE TO THE CITY, TO BE CHARGED FROM THE APPROPRIATION FOR SUBSIDIES AND DONATIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to provide, as it does hereby provide financial assistance to the bereaved family of the late Emilio Tamayo, a former member of the Sangguniang Panlungsod, Quezon City, for the continuous years of service from 1988-1998, who died on December 22, 2011, in the amount of One Hundred Thousand Pesos (P100,000.00) in recognition of his dedicated and exemplary service to the city, to be charged from the appropriation for Subsidies and Donations of the 2012 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
