SP-1207, S-2002, AS AMENDED BY SP-1860, S-2008, TO BE CHARGED FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OF FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
