A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO METRO OIL SUBIC, INC., FOR THE CONSTRUCTION AND OPERATION OF A GASOLINE FILLING STATION TO BE LOCATED AT THE CORNER OF E. DELOS SANTOS AVENUE AND COL. BONNY SERRANO AVENUE, CUBAO, QUEZON CITY.

WHEREAS, petitioner Metro Oil Subic, Inc., a business entity duly registered under Philippine laws, is applying for a Special Use Permit (SUP) to be used for the construction and operation of a Gasoline Filling Station located at the corner of E. Delos Santos Avenue and Col. Bonny Serrano Avenue, Cubao, Quezon City;

WHEREAS, fuel stations are among the uses that require a Special Use Permit upon authorization from the Quezon City Council as provided in Ordinance No. SP-918, S-2000, otherwise known as the Quezon City Comprehensive Zoning Ordinance of 2000;

WHEREAS, Metro Oil Subic, Inc. has complied with the necessary requirements for the issuance of a Special Use Permit as mandated by the Quezon City Comprehensive Zoning Ordinance;

WHEREAS, the construction and operation of a gasoline filling station will provide employment and promote economic development in the City.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the issuance of a Special Use Permit to Metro Oil Subic, Inc., for the construction and operation of a gasoline filling station to be located at the corner of E. Delos Santos Avenue and Col. Bonny Serrano Avenue, Cubao, Quezon City.


