RESOLUTION NO. SP- 5509, S-2012

A RESOLUTION URGING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO EXTEND FINANCIAL ASSISTANCE TO THE NOVEMBER 19, 2011 VICTIMS OF FIRE THAT BURNED THE RESIDENTIAL HOUSES OF MORE THAN SEVEN HUNDRED (700) FAMILIES AT NIA ROAD, BARANGAY PINYAHAN, THIS CITY, AT TWO THOUSAND PESOS (PHP 2,000.00) EACH FAMILY HOMEOWNER AND ONE THOUSAND PESOS (PHP1,000.00) EACH FAMILY RENTER/SHARER, WHICH SHALL BE TAKEN FROM THE CALAMITY FUND OF THE CITY GOVERNMENT OR FROM ANY AVAILABLE FUNDS THEREOF.

WHEREAS, on November 19, 2011, Barangay Pinyahan was hit by fire that ravaged the houses of more than seven hundred (700) families in NIA Road who are now in dire need of financial assistance most especially from the City Government;


WHEREAS, due to the occurrence of such unfortunate and devastating circumstances, they are experiencing financial difficulties and must therefore be provided with assistance in the form of cash; X

WHEREAS, under the Local Government Code, local government units are empowered to adopt measures to protect the inhabitants of the City from the harmful effects of man-made or natural disasters or calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and in their return to productive livelihood following said event.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby urge the City Mayor, Honorable Herbert M. Bautista, to extend financial assistance to the November 19, 2011 victims of fire that burned the residential houses of more than seven hundred (700) families at NIA Road, Barangay Pinyahan, this city, at Two Thousand Pesos (Php2,000.00) each family homeowner and One Thousand Pesos (Php1,000.00) each family renter/sharer, which shall be taken from the calamity fund of the city government or from any available funds thereof.
