RESOLUTION NO. SP- **5515**, S-2012

A RESOLUTION EARNESTLY URGING ALL BARANGAYS OF QUEZON CITY TO INCLUDE IN THEIR ANNUAL BUDGET THE ANNUAL DUES OF THE LIGA NG MGA BARANGAY KAGAWAD, SECRETARY AND TREASURER TO FUND THE FEDERATIONS' OPERATIONAL EXPENSES.

WHEREAS, Section 508 of the Local Government Code of 1991 states that vice governors, vice mayors, sanggunian members of barangay, municipalities, components cities, highly urbanized cities and provinces, and other elective local officials of the local government units, including those of the Metropolitan Manila area and any metropolitan political subdivisions, may form their respective leagues of federations, subject to applicable provisions of this Title and pertinent provisions of this Code;

WHEREAS, Section 509 of the said Code states that the leagues or federations shall adopt a constitution and by-laws which shall govern their internal organization and operation. Provided, that said constitution and by-laws shall conform to the provisions of the Constitution and existing laws;

WHEREAS, Section 510 of the said Code states that the leagues and federations may derive their funds from contributions of individual league or federation members or from fund-raising projects or activities. The local government unit concerned may appropriate funds to support the leagues or federation organized pursuant to this section, subject to the availability of funds;


WHEREAS, the Liga ng mga Barangay Kagawad, Secretary, Treasurer is created by authority of law and therefore invested with legal personality and juridical capacity, hence, collection of dues chargeable to barangay funds, subject to availability thereof, is legally allowed;

WHEREAS, the annual dues will also cover much needed benefits of all Kagawad, Secretary, Treasurer including medical, death and disaster assistance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to urge, as it does hereby earnestly urge all Barangays of Quezon City to include in their Annual Budget the annual dues of the Liga ng mga Barangay Kagawad, Secretary and Treasurer to fund the federations' operational expenses.
