RESOLUTION NO. SP- **5518**, S-2012

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE HERBERT M. BAUTISTA, TO PURCHASE TWENTY SIX (26) UNITS OF MOTOR VEHICLES INTENDED FOR THE QUEZON CITY COUNCILORS AMOUNTING TO A TOTAL OF TWENTY NINE MILLION THREE HUNDRED THIRTY THREE THOUSAND FIVE HUNDRED FORTY PESOS AND SEVENTY EIGHT CENTAVOS (P29,333,540.78) TO BE CHARGED UNDER THE CITY MAYOR'S OFFICE FUND.

WHEREAS, the Quezon City Council requested for motor vehicles that will help facilitate the mobility and efficient operation of their official duties and functions;

WHEREAS, the motor vehicles that will be procured are automatic transmission pick ups, with the following specifications:

2.5L Direct Injection diesel, 40in-line DOHC 16-Valve Turbocharged (VGT) and intercooled DI Diesel (4D56) common rail direct injection. Single dry plate with diaphragm spring, 4-speed a/t, independent double wishbone with coil springs and stabilizer bar, rigid elliptic leaf springs with telescopic shock absorbers, 16" Ventilated discs, 11.6" leading and trailing drums, rack and pinion, 4x2 A/T 12MY, 4-spoke leather-wrapped with silver-accent.


WHEREAS, pursuant to Administrative Order No. 15, amending Administrative Order No. 233, Series of 2008, the Honorable City Mayor Herbert M. Bautista has already sought permission and authorization from the DILG in his letter addressed to Juan Jovian E. Inginierno, CESO IV, City Director of DILG for the acquisition of the above-described motor vehicles amounting to Php 29,333,540.78, which amount is already included in the 2012 Annual Budget of the City Government;

WHEREAS, pursuant to Section 455 (b) (1) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the city mayor shall represent the City in all its transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the City Mayor, Honorable Herbert M. Bautista, to purchase Twenty Six (26) units of motor vehicles intended for the Quezon City Councilors amounting to a total of Twenty Nine Million Three Hundred Thirty Three Thousand Five Hundred Forty Pesos and Seventy Eight Centavos (P29,333,540.78) to be charged under the City Mayor's Office fund.
