WHEREAS, the process of annual registration, notwithstanding its noble intent, sometimes deprived the end-users of possible choices that they may choose to fit their intended specifications or quality;

WHEREAS, to grant an array of possible qualified suppliers/contractors to this City, a quarterly accreditation is seen to allow the local government of Quezon City to choose from authorized persons or entities who can offer the best materials or the best project for the betterment of this City.


NOW, THEREFORE,
