RESOLUTION NO. SP- 5570, S-2012

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE FORMER BARANGAY CAPTAIN ROSARITA CASTILLO OF BARANGAY PAYATAS WHO DIED ON JANUARY 16, 2012 IN THE AMOUNT OF FIFTY FIVE THOUSAND PESOS (P55,000.00) TO BE CHARGED AGAINST THE APPROPRIATIONS FOR GRANTS, AIDS AND SUBSIDIES OF THE OFFICE OF THE CITY MAYOR UNDER THE 2012 ANNUAL BUDGET OF QUEZON CITY OR FROM ANY AVAILABLE FUNDS FOR THE PURPOSE.
