A RESOLUTION EXTENDING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY AND SURVIVING HEIRS OF THE LATE FORMER BARANGAY KAGAWAD, PEDRO R. BALMACEDA OF BARANGAY SAN MARTIN DE PORRES, DISTRICT IV, THIS CITY, IN THE AMOUNT OF FORTY THOUSAND PESOS (P40,000.00) AS PROVIDED FOR IN ORDINANCE NO. SP-1207, S-2002, AS AMENDED BY ORDINANCE NO. SP-1860, S-2008, TO BE CHARGED AGAINST THE APPROPRIATION FOR GRANTS, SUBSIDIES, AND CONTRIBUTIONS OF THE 2012 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.
