RESOLUTION NO. SP- 5581, S-2012

A RESOLUTION EARNESTLY REQUESTING HONORABLE MAYOR HERBERT M. BAUTISTA TO PUT UP A MARKER WHERE THE LATE U.P. PROFESSOR MA. LOURDES ESTELLA-SIMBULAN DIED TO SYMBOLIZE QUEZON CITY'S ADVOCACY TO MAKE COMMONWEALTH AVENUE ONE OF THE COUNTRY'S SAFEST THOROUGHFARES AND TO RECOGNIZE THE CONCERTED EFFORTS OF THE CITY AND OF THE UNIVERSITY OF THE PHILIPPINES.

WHEREAS, there is a need to honor the innocent lives which were lost along Commonwealth Avenue, Quezon City through a marker expressing the City's advocacy to ensure the safety of motorist and the general riding public when traversing and avenue;

WHEREAS, there is a commitment from the University of the Philippines administration headed by U.P. President Alfredo E. Pascual in collaboration with the U.P. College of Mass Communications to secure the imprimatur of Hon. Mayor Herbert M. Bautista to put up a marker in front of U.P. Ayala Techno Hub which is near the spot where the late U.P. Professor Ma. Lourdes Estella-Simbulan figured in a vehicular accident and later died;

WHEREAS, said marker shall have the following words inscribed on it:

"This Marker serves as an enduring symbol of Quezon City's unwavering commitment to make Commonwealth Avenue one of the safest thoroughfares in the Philippines";


"This Marker honors the victims of road accidents and their families who have spurred the Quezon City Government to ensure the safety of its motorist, riding public and pedestrians and reawakened the deep civic duty of the University of the Philippines as a viable partner in championing road safety advocacies";

"This Marker is in memory of the late Professor Ma. Lourdes Estella-Simbulan and of lives that were lost under similar circumstances catalyzing the Quezon City Government and the University of the Philippines to institutionalize road safety advocacies and ensure that not a single life has been lost in vain."


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to request, as it does hereby request Honorable Mayor Herbert M. Bautista to put up a marker where the late U.P. Professor Ma. Lourdes Estella-Simbulan died to symbolize Quezon City's advocacy to make Commonwealth Avenue one of the country's safest thoroughfares and to recognize the concerted efforts of the City and of the University of the Philippines.
