WHEREAS, synchronizing time will reduce confusion as to the official time especially when there are events and important occasions such as flag raising ceremonies and New Year celebrations;


WHEREAS, Presidential Decree No. 1149, assigned PAGASA as the official agency that will handle the dissemination of the Philippine Standard Time (PST). One of the PAGASA's eight (8) major units, the Atmospheric, Geophysical and Space Sciences Branch (AGSSB) operates and maintain a timing system through its Time Service Unit (TSU).
