WHEREAS, Project Skill-Lista Program is a joint pilot project of the City Government through P.E.S.O. and the Department of Labor and Employment (DOLE-NCR);

WHEREAS, this massive skills mapping activity shall cover one hundred forty two (142) barangays with support from the Punong Barangay and the private sector to be accredited as Skills Registration Center in the barangay;

WHEREAS, Project Skill-Lista is anchored in the City Comprehensive Development Plan;

WHEREAS, there is a need to speed up employment facilitation by bringing the City's Employment Program through the barangay level;

WHEREAS, it is a declared policy of the state to promote full employment and equality of employment opportunities for all;

WHEREAS, Republic Act No. 8759 mandated the establishment of Public Employment and Service Office (P.E.S.O.) in every city to provide employment opportunities;




NOW, THEREFORE,
