RESOLUTION NO. SP. 5598 S-2012

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THIRTY FIVE (35) FAMILIES WHO WERE VICTIMS OF FIRE THAT OCCURRED ON FEBRUARY 29, 2012 AT GREMVILLE SUBDIVISION, BARANGAY TANDANG SORA, QUEZON CITY AT TWO THOUSAND PESOS (P2,000.00) PER FAMILY OWNER AND ONE THOUSAND PESOS (P1,000.00) PER FAMILY RENTER/SHARER TO BE TAKEN FROM THE APPROPRIATIONS FOR GRANTS, AIDS AND SUBSIDIES OF THE OFFICE OF THE CITY MAYOR UNDER THE 2012 ANNUAL BUDGET OR FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT.

WHEREAS, under Section 458 (a) (1) (iv) of the Local Government Code, the City Council shall adopt measures to provide relief services and assistance for victims during and in the aftermath of disasters or calamities;

WHEREAS, on February 29, 2012, a fire occurred at Gremville Subdivision, Barangay Tandang Sora, Quezon City that affected thirty five (35) families;

WHEREAS, the City Government should extend financial assistance in order to alleviate the plight of said fire victims.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to grant, as it does hereby grant financial assistance to thirty five (35) families who were victims of fire that occurred on February 29, 2012 at Gremville Subdivision, Barangay Tandang Sora, Quezon City at Two Thousand Pesos (P2,000.00) per family owner and One Thousand Pesos (P1,000.00) per family renter/sharer, to be taken from the appropriations for Grants, Aids and Subsidies of the Office of the City Mayor under the 2012 Annual Budget of the Quezon City Government or from any available funds of the City Government.

RESOLVED, FURTHER, that the Social Services and Development Department shall, in coordination with Barangay Commonwealth, facilitate the granting of financial assistance to the said fire victims.
