RESOLUTION NO. SP- 5600, S-2012.

A RESOLUTION AUTHORIZING THE OFFICE OF HONORABLE PRECIOUS HIPOLITO CASTELO, CITY COUNCILOR, 2ND DISTRICT, QUEZON CITY, TO PURCHASE ONE (1) UNIT OF MOTOR VEHICLE INTENDED FOR MONITORING OF PROGRAMS AND PROJECTS OF SAID OFFICE, AMOUNTING TO SEVEN HUNDRED SEVENTY THREE THOUSAND SEVEN HUNDRED TWENTY PESOS (P773,720.00) TO BE CHARGED TO THE OFFICE OF THE CITY COUNCILOR.

WHEREAS, the motor vehicle that will be procured is described as follows:

2.5L Diesel Van: EURO2 Engine, 4D56 2.5 liter, Diesel Engine, 4 cylinder in line S)HC fuel injected engine, power steering, 5 speed column shift manual transmission, 72 horsepower, 4,200 RPM, GVW 2,205 kgs. body and payload 1,140 kgs., 5.01 x 14" steel rims with 185 SRI x 14:8 PRT tires, front seat belts, analog clock, stereo, power steering, dual a/c, 8 DIP zero rust paint process with 3 years anti rust warranty, FREE: Tint, Matting and early warning device (EWD).



Ingeniero, CESO IV, City Director of DILG for the acquisition of the above-described motor vehicle amounting to P773,720.00 which amount is included in the 2012 Annual Budget of the City Government under the City Council, Quezon City;

WHEREAS, pursuant to Section 455 (b) (1) of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", the City Mayor shall represent the City in all its transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

BE IT RESOLVED BY THE QUEZON CITY COUNCIL IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize the Office of Honorable Precious Hipolito Castelo, City Councilor, 2nd District, Quezon City, to purchase one (1) unit of motor vehicle intended for monitoring purposes of said Office, amounting to Seven Hundred Seventy Three Thousand Seven Hundred Twenty Pesos (P773,720.00) to be charged to the Office of the City Councilor.
