A RESOLUTION RESPECTFULLY RECOMMENDING TO HIS HONOR, MAYOR HERBERT M. BAUTISTA, CONSTRUCTION OF A HEALTH CENTER IN BARANGAY BALON-BATO, DISTRICT II, THIS CITY, THAT WOULD SERVE THE PRIMARY HEALTH CARE OF BOTH BARANGAY BALON-BATO AND UNANG SIGAW.

WHEREAS, Barangay Balon-Bato, with a population of almost eight thousand, does not have its own health center and its residents have to contend with going to the health center of Barangay Baesa;


WHEREAS, in response to the request of the Barangay Officials and the constituents of said Barangay, there is an imperative need for the City Government to consider the feasibility of expanding the health care service in the area through the construction of a Health Center in Balon-Bato preferably at Teachers' Bliss - to cater the needs not only of Balon-Bato but also that of Barangay Unang Sigaw which have a combined population of Fourteen Thousand Five Hundred (14,500).


